- 10. Adams Co Activity Stephen McFadden is at World Ag Expo in Tulare, CA.

11. Community Updates

- a. Othello Shawn Logan: Annual Chamber banquet Friday, Feb 28. Lions Park received \$350,000 for ball field improvement projects. RCO Grant cycle – applying to add even more to Lions Park. John Lallas: McCain Foods project is under way. A lot going on, waste treatment plant final approval received.
- b. **Ritzville** Mike Schrag. City is dealing with questions about quiet zone issues. Citizens and council had a meeting to discuss quiet zone possibility to cut down on the train noise, especially at night. Economic issues and a lot to consider before forcing it. It would require a lot of liability insurance and a lot of concrete barriers.
- c. Lind Paula Bell. Lind Town Council members attended the Ritzville quiet zone meeting and found it very informative. Wind Farm sparking interest in local housing. CDBG project paperwork being completed. Mid-Columbia 99ers, a female fly group – offering to paint town's name on airport runway. PJ Jacobsen: Chamber is getting discouraged, not getting turn out for any of their events. Six active members now and they have decided to lay low this year and only do the parade in June.
- d. **Washtucna** Lloyd Stoess. Community Center/Museum is getting new roof next week. Sonny's is getting close to opening. Church furnace failed in January, cleaning out all the smoke damage. Lions Club bingo 5pm dinner, 6pm bingo this Saturday, February 15.
- e. Adams County John Marshall. Ribbon cutting at Othello WSU bee research facility on March 6 at 3pm. Working with Clearway Energy on project details. Union contracts have been accepted. Non-union contracts are under process. In Olympia every week visiting legislatures and discussing important topics.
- f. **Port of Othello** Chris Faix. Sold more Bruce ground, all 42-acres by Betaseed have been sold now, bringing their jobs from 50 to 70. Hanger 4 (10 bays) bid packets going out next week, waiting list for potential renters. Interest in 26 & Reynolds property.
- g. Avista Ian Eccles. A lot of resources are dedicated to Adams County right now. Starting to permit from Saddle Mountain to Othello. Smart meters have been installed throughout the county, Othello is wrapping up this week. 13 ways survey results are

being studied and report is coming.

- h. Columbia Basin Railroad Patrick Boss. Connell Rail Interchange Coalition went to Olympia and met with several legislatures. Current proposal would allow the legislature to push back the project for a year or two and hold the \$10 million funding for when project is ready to proceed. If shipping cars continue to increase it could cause major congestion issues for the shippers. Connell holds the major issue and in 2-3 years it could hurt economic development in the region.
- Coulee Corridor Ken Caylor. Ribbon cutting on March 27 in Othello at 9am for new corridor kiosks, Warden will follow at 11am. April 3 – Grand Coulee. April 17th – Soap Lake & Coulee City.
- j. **Ice Age Floods** Lloyd Stoess. The Scablander newsletter is done. Spring hike Sat March 7, Staircase rapids. April 24, at Ritz Theatre, geologist coming from Oregon, giving a talk about Mt St Helens then and now.
